Privacy Notice for the Trends in International Mathematics and Science Study (TIMSS) Wales 2027

Background

The TIMSS 2027 study is organised by the International Association for the Evaluation of Educational Achievement (IEA). Studies such as TIMSS show us how education in Wales compares to that in other countries around the world; what we are good at, and where we can do better. By asking headteachers, teachers, parents and pupils about the school, teaching, attitudes and the learning environment, we can understand different things about the factors that affect learning and find ways to make schools better for everyone.

We (Welsh Government) (along with IEA) are data controllers for the personal data processed as part of TIMSS 2027 in Wales. We will process it in line with our public task and the official authority vested in us. Pearson UK, along with their subcontractors the University College London - Institute of Education (UCL - IOE) and Page Bros Group, are our data processors.

How we use your data

Headteachers/Teachers

We use headteachers' names to personalise your school study materials, and the headteacher and the school co-ordinator's email address to correspond with you throughout the project. We may also correspond with other school staff in connection with the project e.g. IT support staff

Pupils and Parents

We use the names and date of birth of pupils in your school to randomly select pupils to take part in TIMSS.

We put the information from TIMSS with other information which we already have. This includes information in the national pupil database provided to us by your school such as attendance (please see our main privacy notice for all statutory data collection here: [Data management information: privacy notice | GOV.WALES](#)). Some of the information we ask for, or which we already have and will use in TIMSS is called sensitive personal data. This includes your child's name, date of birth, gender,

unique pupil number, the languages your child speaks at home, and whether you, your child, or any other parent/carer was born in the United Kingdom.

We do not publish the answers of any individuals to any question, and neither children nor the school can be identified from any report or publication.

What do we do with your information?

After you have taken part in the TIMSS study, Pearson UK will anonymise your personal data (i.e. they will remove your name and anything else which could be used to identify you/your child or the school and replace it with a code) and they will send it to organisations in other countries. They will put the anonymised data with that from the other (approximately 60 countries) taking part in TIMSS.

Your information allows us to carry out our public task and in the exercise of our official authority for the following purposes.

- Research Purposes: To understand mathematics and science capabilities of year 5 learners in Wales and internationally, the ways students learn and how to make schools better for everyone.
- Publication purposes (carried out in a way that ensures individual children and young people cannot be identified): National report published on the gov.wales website, developed by Pearson UK's subcontractors.

We will only use your data for statistics and research purposes at every stage of the process.

Who do we share your information with?

We will not share your personal data with any organisations who are not contracted to process your data on our behalf. We may share your TIMSS responses with trusted Third-party organisations whom we have a data processing agreement with; however this does **not** include your personal data.

Transfer to Countries Outside EEA.

Pearson UK (on our behalf) will anonymise the data and send it to the TIMSS 2027 study to IEA and their contractors. You will not be identifiable from this information.

How long will we keep your information?

Welsh Government will keep TIMSS 2027 study data for a period of 10 years after the end of the contract in 2029. After this point the data will be anonymised in line with best practices and will continue to be used only for statistical and research purposes.

Your rights in relation to your information

You have the right to:

- access to the personal data that WG are processing about you;
- require us to rectify inaccuracies in that data;
- the right (in certain circumstances) to object to processing;
- the right for your data to be 'erased';
- lodge a complaint with the Information Commissioner's Office (ICO) who is our independent regulator for data protection.
