

# Provisional list of qualifications that will no longer be funded for 16-19 learners in England, from 2024/25

## Which qualifications Pearson are appealing and how you can help

### Introduction

The first stage of the Review is underway. On 11 May 2022, the DfE published the [provisional list of qualifications](#) that will no longer be funded from the start of the academic year 2024/25 because they overlap with T Level routes in Waves 1 and 2.

The qualifications are proposed to be withdrawn for 16-19 study programme learners, in England, only. It does not affect funding outside of England, and it does not affect 19+ funded learners or learners who take these qualifications as part of apprenticeships.

Awarding bodies have been invited to appeal qualifications where they can evidence one or more of the following:

- They are academic rather than technical qualifications: i.e., they support progression into higher level, including degree level, FE and HE academic courses.
- They do not overlap with T Level routes in Waves 1 and 2.
- They are linked to T Level routes in Waves 3 and 4 and therefore should not be considered for removal until academic year 2025/26.

Awarding body appeals must be submitted by 8 July 2022, and the final list of qualifications that will not be funded from the start of the academic year 2024/25 will be published in September 2022.

**We will be appealing 14 qualifications on the list, which we believe should remain eligible for funding for learners in 2024/25.**

### Do keep in mind:

- The confirmed list of qualifications that will be removed for funding in 2024/25 will be available in September 2022.
- The process does not affect qualification funding in 2022/23 and 2023/24. You can continue to register onto all qualifications on the list for the academic years 2022/23 and 2023/24, with confidence.
- All other BTEC Nationals in Applied Science, Health and Social Care, Construction, Engineering, CPLD (360 GLH), Applied Psychology, Applied Biology are not affected. The process does not affect qualification funding in 2022/23, 2023/24, and 2024/25. These qualifications will all be subject to reform and reapproval in 2025/26.
