### The week in a nutshell

This week **Nadhim Zahawi** announced, during the **Second Reading of the Skills and Post-16 Education Bill**, that the Government's **level 3 reform timetable would be extended by a year**, meaning no funding will be removed from qualifications overlapping with T Levels until 2024 at the earliest. Though this was welcomed, many also felt the extension did not go far enough. During the debate many MPs spoke in favour of retaining high quality Applied General and BTEC qualifications. The Secretary of State also announced relaxations relating to English and maths exist requirements for T Levels, in order to encourage more students to take the new qualifications.

**Ofsted** is to **accelerate inspections** to consider how schools and colleges are recovering from the pandemic. Chief Inspector, **Amanda Spielman**, in a speech to the AoC, set this policy out. She also highlighted the role Ofsted will be playing in the government's new Local Skills Inspection Plans

And as part of anti-bullying week, Children's Minister **Will Quince** announced funding to support **anti-bullying initiatives** and provided schools with money to promote **pupil wellbeing**.

### Top stories

#### Skills Bill **received second reading**, Zahawi announced changes to T Levels

- The Skills and Post-16 Education Bill received its second reading in the Commons on Monday, providing MPs with their first opportunity to debate the Bill.
- In his opening remarks, Education Secretary Nadhim Zahawi told the House that they would be removing the maths and English qualification from the T Level exit requirements, to make them more accessible.
- He also announced that the removal of funding for Applied General and BTEC qualifications would be extended by one year.

#### DfE **announced support** for schools to tackle bullying and staff wellbeing

- Childrens Minister Will Quince announced that five leading organisations would receive a combined total of over £1m to provide programmes and support to schools and colleges to tackle bullying.
- The Government also announced a new support scheme for school leaders worth £760,000 to promote good wellbeing across pupils, teachers, and school and college staff.
- At the same time, [the new Education Staff Wellbeing Charter](#) was published, setting out commitments from the Government, Ofsted, education unions and charities, to promote the mental health of the workforce.

#### Ofsted **instructed** to accelerate inspections

- The regulator has been asked by the Government to inspect all schools and FE providers by summer 2025, to give a quicker assessment of how education is recovering from the pandemic.

- Beginning with last term’s inspections, all schools and FE providers will be inspected at least once by summer 2025. The total extra funding for education inspections over the next three financial years, over and above Ofsted’s current spend, is £23.85m.

### Amanda Spielman addressed AoC Annual Conference

- Ofsted’s chief inspector spoke at the annual conference of the Association of Colleges, covering the need to accelerate inspections of schools and colleges.
- She also noted her support for assessing “the extent to which colleges have regard to local skills” adding that they’d “had concerns about mismatches in the past between courses that are popular and courses that really open doors.”


### Welsh Government launched the Young Person’s Guarantee

- Economy Minister Vaughan Gething launched the scheme, which will provide everyone under-25 with the offer of work, education, training or self-employment.
- This will include “one simple route” to access the Guarantee via Working Wales – with support and advice available in-person and virtually on apprenticeships, traineeships, courses and careers.
