The week in a nutshell

The **Times Education Commission** published its final report, calling for an education reset. The report entitled *Bringing out the best: How to transform education and unleash the potential of every child,* makes a number of recommendations for change across the education system, from early years through to university. Its recommendation for a British Baccalaureate at 18 and fewer exams at 16 is the latest contribution to the ongoing debate as to whether the current system of assessment is fit for purpose. However, the government is clear that it is not considering changes, having reformed exams under Michael Gove.

At the **Education Committee** on Wednesday, Minister for HE & FE, **Michelle Donelan** took MPs' questions. In answering she added to the strong feeling that change is on the way for the apprenticeship levy, saying that it could be more flexible to enable employers to spend money in "the right way". Perhaps luckily for the Minister, the **Public Accounts Committee** report on financial sustainability of the higher education in England came later in the week. MPs were very critical of both the OfS and DfE.

Times Education Commission report calls for education reset

- The Times Education Commission has published its final report after a year-long evaluation of Britain's
 whole education system, conducted by a team of 22 commissioners from across business, education,
 science, the arts and government.
- The report recommends a 12-point plan for education, which includes:
 - A British Baccalaureate offering broader academic and vocational qualifications at 18, and a slimmed-down set of exams at 16.
 - 'Electives premium' offered for all schools to be spent on activities including drama, music, dance and sport and a National Citizen Service experience for every pupil, with volunteering and outdoor pursuits expeditions to ensure that the co-curricular activities enjoyed by the most advantaged become available to all.
 - Making the most of tech: A laptop or tablet for every child, greater use of artificial intelligence in schools, colleges and universities to personalise learning, reduce teacher workload and prepare young people better for future employment.
 - A reformed Ofsted: Ofsted should work collaboratively with schools to secure sustained improvement, rather than operating through fear.
 - A 15-year strategy for education: The strategy should be drawn up in consultation with business leaders, scientists, local mayors, civic leaders and cultural figures..
- The report has been backed by: former prime ministers Tony Blair and John Major; former education secretaries Justine Greening, Lord Blunkett and Lord Baker; and business leaders; creative industry leaders; and Nobel winning scientists.

Public Accounts Committee publishes report on financial sustainability of higher education in England

- The Committee's report criticises the Office for Students (OfS) for not making "sufficient progress in getting
 a grip" on the long-term problems facing the sector. DfE also comes in fro criticism for failing to hold OfS
 properly to account.
- As well as highlighting the impact on long-term financial viability caused a rise in those institutions with inyear deficits, the committee of MPs also called out concerns about the sector's reliance on income from overseas students.
- Falling student satisfaction was also picked up on, and the DfE was also criticised for failing to predict the ongoing impact of pandemic-related disruption to A levels.

Michele Donelan gives evidence to Education Select Committee

- As part of its regular round of accountability hearings, the Education Committee heard evidence from Michelle Donelan, Minister for HE & FE.
- On access to HE, she told MPs HE access plans would now be more about "getting on, than getting in".

 Donelan also said that alternative student finance will be done alongside the new Lifelong Loan Entitlement.
- When asked about the apprenticeship levy, the Minister said it could be more flexible so employers can spend funds in the right way. She also said not to expect flexibilities around the T Level work placements, as they would be "damaging".
