The week in a nutshell

In a relatively quiet week for education policy as activity winds down for recess, the Petitions Committee held a debate on BTEC qualifications after the *Protect Student Choice* campaign's petition received more than 108,000 signatures. The debate featured arguments in favour of BTECs and applied general qualifications from MPs across the political spectrum. It will be interesting to see whether the new Prime Minister and their team of ministers will consider the weight of public and political support for choice at age 16.

Also this week, Ofsted published its summer 2022 briefings on COVID-19 impact and recovery, DfE put out an evaluation of the free level 3 course offer, provisional school funding allocations were announced by Will Quince MP, and initial funding allocations were set out for the [National Tutoring Programme](#). Meanwhile, a [teacher pay increase](#) of 5-8.9 per cent was announced, which was criticised by unions and industry bodies as a real-terms pay cut.

The [Schools Bill](#) has now completed report stage in the House of Lords, with its Third Reading scheduled for 14 September. Whether the Bill is retained by an incoming ministerial team is up for debate, especially given the changes already made to the draft legislation following opposition in the House of Lords.

Top stories

Debate held in response to Protect Student Choice BTEC petition

- On Monday, the Petitions Committee held a [debate on BTEC qualifications](#). 17 MPs from across the three main English parties spoke in support of BTECs. They highlighted numerous local case studies and benefits of these qualifications, including social mobility and choice for students.
- They also highlighted concerns around Government plans to defund BTECs in order to make way for T Levels, including, amongst others, the rushed process, lack of transparency and issues around work placements.
- Parliamentary Under-Secretary of State for Education Andrea Jenkyns MP, who studied a BTEC, reiterated the government's current policy direction.

Ofsted publishes new reports on pandemic impact and education recovery efforts

- As part of its ongoing research series, this week Ofsted published its latest briefings covering [Early Years](#), [Schools](#), and [FE and Skills provider](#) inspections conducted in the 2022 summer term.
- Continuing issues included slower development and lower attainment than pre-pandemic levels, staff recruitment and retention issues across the board, lower participation in early years and FE level education, and evidence of more anxiety around exams.
- However, improvements have been identified in terms of attendance, behaviour and providers' efforts to recover from the pandemic's effects. Chief Inspector Amanda Spielman described providers as responding with "creativity and resilience".

School funding allocations confirmed through the National Funding Formulae

- On Tuesday, School Standards Minister Will Quince published a [written statement](#) announcing [provisional funding allocations](#) for 2023-24.
- Overall core schools funding is set to increase by £1.5bn on the previous year, with a 5 per cent funding increase per head for the high needs 2-18 population, and a 1.9 per cent increase per pupil for mainstream schools. The statement also notes that funding for disadvantaged pupils will see greater increases.
- The confirmed allocations will be published in December, based on the latest pupil data.

DfE launches new consultation on FE funding and accountability system implementation

- On Thursday the DfE launched a new [consultation](#) to gather opinions on its proposals for implementing the new further education funding and accountability system.
- It follows a consultation last year regarding reforms to the adult skills funding system and the FE accountability system. They now want to know how to take these reforms forward.
- The consultation is open until 21 September.

DfE: Evaluation of the level 3 free courses for jobs offer

- The **Department for Education** has published a report on the [findings from an independent evaluation](#) of the level 3 free courses for jobs offer and the impact it has had on adult learners and providers.
- Almost three quarters (74%) of surveyed learners say they would have been very unlikely, or slightly less likely, to have begun their L3 course had it not been free. They say they would not have been able to fund the course themselves, most typically due to: unemployment, low income, childcare costs, family commitments, or ineligibility for learner loans.
- Around two thirds (64%) of surveyed providers agree that the Free Courses for Jobs offer has enabled their institution to deliver more remote live classes/study groups, or to employ more staff to deliver adult L3 courses (63%).
- Transitioning between levels is a notable concern for some providers, as applicants are often unemployed or come from more deprived areas and cannot readily afford the cost of L1 or L2 courses. One quarter (25%) of learners agree they would have benefitted from prior learning before starting their course – most commonly centring on subject specific knowledge – while just over three in five (61%) disagree.

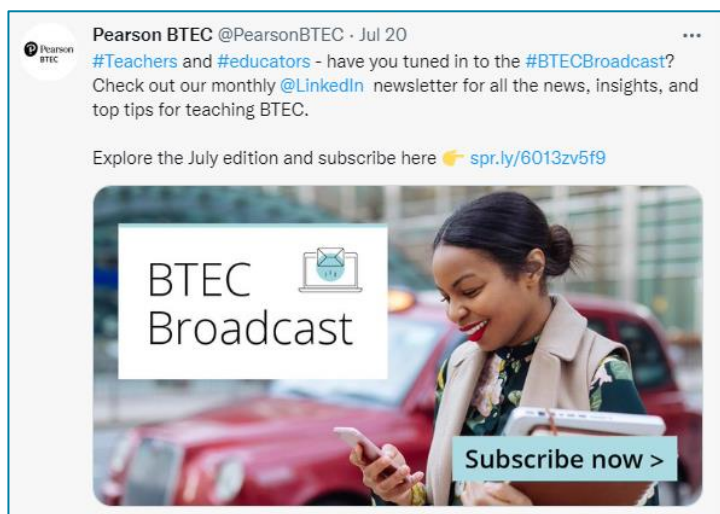
