#### The week in a nutshell



Education Secretary Gillian Keegan gave evidence to the Education Committee for the first time this week, covering strike impact mitigation, the possibility of an undergraduate apprenticeship for maths and physics teaching, social mobility in grammar schools, and how conversations surrounding Rishi Sunak's British Baccalaureate proposal are currently focused on maths to 18. She also announced that the Schools Bill will not progress any further – more detail below.

Meanwhile, the Report of the Commission on the UK's Future, led by former Prime Minister Gordon Brown, was published this week. Among its wide-ranging recommendations on devolution were consolidating adult education and skills funding streams, improving democratic accountability in LSIPs, and the administrative devolution and expansion of Jobcentre Plus.

#### Gillian Keegan tells the Education Select Committee that the Schools Bill will progress no further

- Education Secretary Gillian Keegan has confirmed to the Education Committee that the flagship Schools Bill will not be progressing any further.
- She stressed that they remained committed to the principles of the Bill particularly the registration of home-schooled children.
- When asked by committee chair Robin Walker what would come of plans to direct the national funding formula (NFF) to schools based on the levels of deprivation in the areas they served, Keegan said she felt they already had the powers to go make headway without legislative change.

## Resolution Foundation publishes briefing on UK skills, tasks, and training

- The Resolution Foundation has published a briefing note on skills, tasks and training in the UK labour market, as part of its wider Economy 2030 Inquiry. Key findings include:
  - In the last 25 years, the need for social and abstract skills in the workplace has increased, while the employment shares of occupations intensive in manual skills have fallen. Wages have grown particularly strongly for jobs that require a significant amount of abstract reasoning.
  - Despite these fundamental shifts in the skills needed to thrive in the workplace, training is in decline: the proportion of workers who report that they have received work-related training in the past 3 months has fallen from 29 per cent in 2002 to 24 per cent in 2020. What training does take place is acting to increase, not reduce, inequalities.
  - The UK has seen falling rates of job mobility in recent decades, with much of the changing patterns of occupational structure driven by entry and exit of workers as opposed to employed workers transitioning from declining to expanding sectors.

## HEPI publishes policy note on students' views on digital learning resources

- The Higher Education Policy Institute (HEPI) has published a policy note based on polling carried out by UCAS, which compares students' expectations with reality regarding digital learning resources. Key findings include:
  - 45% of students disagree that the online resources at their school or college were better than those at their higher education institution, while 38% agree.
  - The digital resources most widely available to students include lecture slides (92%), online reading lists (84%), and eBooks and e-journals (81%).
  - The most in-demand digital resource is lecture recordings which are currently accessed by 79% of students.
  - 84% of students 'sometimes', 'rarely' or 'never' purchase course books, relying instead on their institution's library.
  - The overwhelming majority of students want digital course books available on one consistent reading platform (55% 'strongly agree' and 32% 'agree').

#### NFER launches teacher workforce dashboard

- Funded by the Nuffield Foundation, the National Foundation for Educational Research (NFER) has launched a new interactive dashboard providing insights into local and national teacher workforce challenges.
- Broken down by local authority, parliamentary constituency, school type and academic subject, the data offers insights into teacher retention, recruitment and shortages while comparing regional data with national averages.
- Its key insights include that the proportion of students who receive Free School Meals correlates with teacher attrition rates, and that there is little difference in teacher retention between schools in Education Investment Areas (EIAs) and other areas.

## Sutton Trust: The recent evolution of Apprenticeships

• A new report published by the **Sutton Trust** has found young people from low-income backgrounds are under-represented in higher and degree level apprenticeships compared to university – alongside a decline in overall apprenticeship starts in recent years, which has been much bigger in areas of high deprivation.
