Option two – On Site Assessment Service

- Profile/Skill Match
- Minimum of six months' experience on category of plant
- Operating category of plant on site to be assessed
- Health and safety knowledge
- Witness testimonies completed by employer or supervisor
- On site practical assessment (minimum of two observations in workplace)*.

*Non-achievement of practical assessment will result in assessor's recommendations, such as re-take, training etc.
